

MRDC Breaks through to War Zone Benaria



The remote Benaria Region in the Hela province is notorious for tribal fights. It is referred to as a war zone and hardly anyone goes there out of fear of being attacked.

There's hardly any presence of government service there. A primary school and an aid post serving over 7,000 people there were built by the ECPNG Church before independence. In 2010, it was decided that the pipeline for the PNG LNG Project would run from the Hides gasfield through the Benaria region into Kikori.

The notorious war zone suddenly became the home of 136 beneficiary clans of the PNGLNG Pipeline Segment 2.

And it was left to MRDC to make the breakthrough. The task was to get into the area and talk to the people about the project and its benefits, create awareness about small businesses and financial inclusion, and open bank accounts for the clans.

Benaria makes up the segment 2 pipeline landowners and have been part of the MRDC's bank account opening program which also covered Segments 1 in the middle of Juha and Hides (Hela), and segment 3 in Paua, Southern Highlands Province.

The July 2019 visit to Benara by MRDC also included officials from Bank South Pacific, the Department of Petroleum, Kumul Petroleum Holdings limited and ExxonMobil.

Team leader and MRDC General Manager for External Affairs and Sustainable Development Imbi Tagune was very pleased with the outcome and his team's effort in Benaria.

"This is a significant breakthrough, to be able to include Benaria in this process. This means the people here will be able to use benefits from the project to improve their lives," said Tagune. He said with the bank account opening completed in Benaria, the next step was to set up the board of the trust company. "Their benefits will flow as soon as the complete board sits and goes over the books before deciding on a date to release the overdue royalty and equity payments."

In total, 186 clan bank accounts for Segments 1, 2 and 3 were opened; 13 clan accounts for Segment 1, 135 for Segment 2 and 38 for Segment 3. These three segments will be represented by one director to the board of the trust company; known as Gas Resources PNGLNG Pipeline Limited.

The trust company will manage all landowner interests for the entire pipeline Segments from 1-8 covering Hela, Gulf, and SHP. It will be a subsidiary of MRDC. So far only two directors have been elected to the board, Oumabe (Segment 7) and Babena (Segment 4 & 5).

The board will comprise of four landowner representatives, the Managing Director for MRDC, Governors for Hela, and Southern Highlands and and Secretary for the Department of Petroleum.

Benaria, Segment 2 was to combine with Segment 3 clan beneficiaries from Homa, Southern Highlands Province to participate in an election process to elect a representative director.

The election process allows for the Major clan chair persons only to nominate and vote. It is hoped this process will be completed before the end of the year.

ExxonMobil has resumed work at Angore PDL 8 in Hela province following a peace ceremony which united rival landowner groups after a year of fighting.

The peace and reconciliation ceremony, held at the Idauwi Community School in August this year, was facilitated by MRDC. It successfully brought an end to long standing dispute among the rival groups, which has seen the destruction and vandalism of machinery and properties. Fight erupted in June 2018 after landowners protested over a non-payment of 35 million kina for "project security". The fight prompted ExxonMobil to abandon work and evacuate its employees to safety. They stayed away for over a year as MRDC led efforts bring peace to the area. The August 2019 ceremony, witnessed by Exxon Mobil, MRDC, KPHL, DPE, OSL and landowner

leaders was a relief for all the stakeholders involved.

Speaking on behalf of the 59 ILGs of Angore, Malex Au, chairman of the ATALA group apologised for the destruction and damage to properties which have resulted in the interruption the company's operations in Angore.

"This is our way of contributing to taking back PNG. We are starting in Angore by bringing peace to our area", said Malex.

"I take this time to say sorry to Exxon Mobil. I take full responsibility for my peoples' actions and today, I personally say sorry."

He was pleased to see ExxonMobil return to resume operations and gave his word on behalf of the people that in future, issues would be addressed in a round table rather than fights.

MRDC's Imbi Tagune called on the people to remember this day and keep the peace in the area. He told them Hela was home to the PNGLNG Project, which was of immense economic importance to the nation.

"You are PNG's Garden. God has blessed Hela. Only through peace can you enjoy the blessings. "That is why we at MRDC promote peace. We lead efforts to find a resolution to conflicts through peaceful means. We proved this when we went into the once notorious Beneria No-Go-Zone to help landowners open bank accounts. We brought peace there, and we have facilitated for peace in Angore. We can expect development and service delivery to flow smoothly."

The leaders presented 15 live pigs to Exxon Mobil as a symbol of reconciliation and renewal of partnership.

Twenty New Dinghies for Boera Village Community Economic Initiative

Boera Village in Central Province have received twenty (20) new outboard motors and dinghies from their LANCO Gas Resources PNGLNG Plant Limited (GR-PNGPNGPL) to promote sustainability through subsistence fishing and farming.

The outboard motors and dinghies were purchased through the Boera Community Infrastructure Trust Fund (CITF), set aside for them as one of the four landowning villages of the PNGLNG Project Plant facility. Their director representing them on the board of GR-PNGLNGPL Ms. Ulato Avei who is also the Chairperson on the board purchased the dinghies as part of a community economic initiative which aims to bring back the culture of subsistence fishing and farming to the village.

The brand new dinghies and outboard motors were purchased from Ela Motors at a cost of up to K530, 000 and were presented to the landowners today (Thursday, 12th of

September) in Koke Hanua, Boera Village.

Avei had also previously donated two fully kitted tractors in March this year to encourage women in agriculture in the pursuit of promoting sustainable development.

GR-PNGLNG PL in its two years of operation has contributed to improving and enhancing the lives of the four impacted villages by building essential infrastructure through their Community Infrastructure Trust Fund (CITF).

Under the management and leader-

Under the management and leadership of MRDC, GR-PNGLNG PL is confident in its capability to help develop the four-landowning villages of the PNGLNG Plant facility. To date, GR-PNGLNGPL has spent a total of K4.4 Million on community infrastructure projects in important sectors like Health and Education. The CITF is a 30 % portion set aside from all landowner payments per the Oil and Gas Act, to build infrastructure projects and support initiatives which benefit the entire community. Another 30% put towards the Future Generations While 40% of any benefit is in cash payments.

As the dinghy left the shores of Daru Island, the people waved goodbye with heavy hearts. They were bidding farewell to one of their visionary leader who would be laid to rest in his Waridoboro village, in the Manawete region Western province.

The name Vincent Kearo is a synonym for leader and guardian to the people of Manawete whom he represented under the Community Mine Continuation Agreement with the Ok Tedi Mine.

He was described as a leader championed the peoples cause and fought hard for benefits to flow to them, especially in negotiating the implementation of Mineral Resources Community Mine Continuation Agreement Holdings (MRCMCAH). This is the landowner company that holds the cash compensation for development purposes for the mine affected communities.

Late Mr Kearo sat on the board of MRCMCAH as one of the founding directors until his untimely passing last month (August).

Fellow Director Kime Sumai, speaking at the funeral service in Daru spoke of Kearo as a man of principle who had virtues that the company was privileged to be associated with. "We recognize and appreciate Vincent Kearo's contribution to the company, and most importantly to the people. He was a strong and true leader who represented the

Manawete people through all the processes and negotiations to come to where we are today," Said Sumai. Sumai urged the young people of Manawete who gathered learn, step up and take over from where late Director Kearo had left off. The Mineral Resources Development company (MRDC) assumed full responsibility of meeting the cost of repatriating the body from Port Moresby to Daru, and onto Waridoboro village, including meeting the cost of family members. A K20,000 was made available for the family to

meet additional expenses as they occurred.

Speaking at the funeral service, Alex Wapia of MRDC conveyed the company's deepest condolences to Kearo's relatives and family and the people of Manawete region for the loss of their leader.

"We have lost a strong leader, in the business circle and in the community here in Western Province. He dedicated his life to serving his people. We at MRDC and MRCMCAH will remember him for a long time," Alex said.

within the Association which started in 2007 and came all the way to 2014 after a long court battle. In 2014 the court advised both faction led by Mr Kapi Natto and Mr Sakai to hold an AGM to elect the office bearers and the faction led by Mr Sakai was then elected and declared by the electoral commis-

The court-ordered election took

place after a struggle for leadership

Majority of the landowners did not agree with the election of Mr Sakai stating that the AGM didn't work out well so they went back to court. It took almost five years for the ruling to come out and on May this year (2019) the court declared the election of Mr Sakai null and void

and ask the electoral commission to conduct another election which Mr John Kapi Natto was elected as the new Chairman by majority of the landowners during the elective AGM.

Mr Kapi Natto said, for the people it was a big relief.

"Because the orders came back that the election didn't go well and that court ordered to conduct an elective AGM within a month so today (Saturday) was the demonstration of it by upholding the laws and the orders" said Kapi-Natto said. During the Elective AGM number of key resolutions was passed with one of them being the Constitution. The constitution has authorised and endorsed 117 ILGs to be part of the constitution so that they are eligible to vote.

"We fulfilled all the court order and the election was done peacefully and transparently in the presence of the electoral commission, and also our security personals that were here so there was no mistreatment of practise, it was done fairly and honestly and the results were declared by the electoral commission." Natto stated.

Kapi-Natto continued by saying that as the chairman he and the new office bearers including executives from the four regions of Hekari, Gasuku, Huri-aporo and Soro-moro will work together to ensure that the people of Namo'Aporo get whatever benefit they have been missing out on.

"It's a big relief for us especially the people in the village who have been suffering for so long. Their royalty and equity has been hampered by the court of the other factions and they have been suffering for the last four to five years. Service delivery was not that fast. Now that with this executive and the confidence that we have, most of us are in some jobs that are highly and more experienced and I believe that there is a light at the end of the tunnel and this management can deliver the service back to the people." Said Kapi-Natto

In concluding Natto said that the victory belongs to the people in the village because they have been waiting for far too long and sadly some have already passed on. but today is a new light and I believe this management has the energy and the confidence and we will try to deliver and take the service back to the people" he said.



The descend of Oil Fields and the rise of Gas Fields in PNG"



In this quarter we will look more into the gas fields of PNG and the important part it plays in the future of PNG.

Gas has been discovered since the 1950s but was not commercialized until 1980s with Hides as the first commercialized gas field and was awarded the first Petroleum Development Licence in PNG before the oil fields were brought online. Hides was granted PDL 1 to provide commercial gas for the gas-powered turbine for the Porgera Gold Mine in Enga province.




Figure 1. Oil and Gas Field in PNG

There are about 22-gas field discovered to date as seen in figure 1 with 4 offshore gas fields while the remaining 18 are onshore gas fields. The estimated gas in place resources still untapped would be around 50TCF from the 22 gas field discovered to date.

This indicates how viable the gas resources is for the future of the PNG. However, accessing and linking these gas fields to a LNG processing plant or the commercial market is still an economic challenge for the operators and the affected resources owners.

With the large amount of gas still yet to be commercialised and the success story of the PNG LNG, it is no doubt the PNG government and its stakeholders will be assessing carefully the Papua LNG and Western LNG for more success stories from gas resources in PNG.

MRDC Drives LANCO Directors training

North OK Tedi Director Mr Lalaman Gaegae is thankful for MRDC's support in this much needed training as he it has made him realise the importance in identifying and knowing individual capabilities and limits, as well as his purpose as a director for his region. The training also highlighted the role of MRDC and how it manages its trustees, in terms of MRCMCA Holdings Corporate Governance, board of director's compliance, roles and responsibilities and what is expected of the directors by major shareholders.

The program also saw other organizations such as Tribal Foundation, AIDAN Limited, EMSTRET Holdings and PNG Institute of Directors share some light on community development, capacity building, as well as start-ups of small and medium enterprises in PNG and how digital technology is driving growth in rural communities.

With Mr James Assan as Chairman and the other seven (7) directors; Richard Zumoi, Lalamana Gaegae, Penai Napu, Kamen Arawak, Debra Sunakiyea, Kime Sumei and Vincent Kearo were all represent their people from the eight regions.
